COVID-19 UPDATE (REVISED)

18 June, 2021

Dear Members,

As the club is getting busier by the day, I wanted to give you an update on some of the work that we have done with regards to keeping members, guests and our entire team as safe as only possible. Whilst the vaccination rate overall in Hong Kong is still relatively low, we are encouraged by the increasing numbers of staff who have registered to get vaccinated or have had their 1st and 2nd Covid-19 vaccination jabs done. On 25th May, management organized a General Staff Meeting to inform, educate and encourage our almost 200 team members to consider participating in our LRC vaccination drive. We have also invited a medical doctor from the University of Hong Kong to speak to our staff and to give them as much information as only possible before deciding to make the trip to the vaccination center. Overall it was a very positive meeting and since we have experienced a sharp increase of staff who are now willing to get vaccinated. To-date, we have 82% of our staff who are in the vaccination program and we expect that by the end of July, most of our employees will have completed 2 jabs.

CHECK-IN PROCEDURES

To expedite the check-in procedure for our members, the following new member check-in policy will be implemented as of **Saturday, June 19**:

- Temperature check.
- Membership card tap-in.
- Scan of "LeaveHomeSafe" app or fill out the LRC Health Declaration Form in electronic or hard copy version.

The guest check-in procedure will remain unchanged.

THE LRC IS MOVING FROM "TYPE B" TO "TYPE C"

As of **Tuesday, June 22**, the Sundeck, the Dining Room, Cocktail Lounge and the Function Room are moving from "Type B" to "Type C" which will allow us to provide you with bigger table formats for dining at the above-mentioned venues.

What is a "Type C" Operation?

- Maximum 6 persons per table.
- Dine-in service until midnight. (Last orders follow Pre-Covid-19 operating hours)
- Maximum 20 participants in any one banquet.
- Members and guests must use (mandatory government requirement) the "LeaveHomeSafe" mobile application, except persons aged under 16 with an accompanying adult.
- Even if members and guests have scanned the "LeaveHomeSafe" venue QR Code when entering the club, they will be required to scan the "LeaveHomeSafe" venue QR code again prior to entering a "Type C" outlet.
- Persons aged under 16 without the company of an adult, and persons aged 65 or above may opt to complete the [attached record form](#).
- All staff working at a "Type C" venue must have the first dose of the Covid-19 vaccine.

For the above-mentioned LRC F&B outlets, we will go back to normal regular pre-Covid operating hours with maximum tables sizes for 6 persons.

QUARANTINE ARRANGEMENTS FOR THOSE WHO HAVE TRAVELLED OUTSIDE OF HONG KONG

Please note that the club is revising its policies for members and guests who have travelled outside of Hong Kong. With immediate effect. Travelers who have returned to Hong Kong and have completed the government's compulsory quarantine arrangements in designated quarantine hotels, are welcome to visit the LRC.

COVID-19 VACCINATION PINS

All fully vaccinated staff have received "Covid-19 Vaccinated" pins, which they all wear as part of their uniforms. Covid-19 pin ceremonies are held approximately every 2 weeks to celebrate and thank our team members for making the LRC a safer place.
