## COVID-19 UPDATE

Dear Members,

As a follow-up on my most recent Covid-19 message from July 13, I would like to give you a further update on the COVID-19 situation at the Club and brief you on what we are currently working on.

### **STAFF VACCINATION**

In our efforts to have all of our team members vaccinated, I am pleased to inform you that we have reached a vaccination rate of **99.5%**. This is an extremely important milestone for us to ensure that all members and their guests feel safe at all times when visiting the LRC. We expect to have 100% of our staff in the vaccination programme by the end of the month.

### **BABY POOL RE-OPENING**

We are delighted to inform you that the Baby Pool will re-open as of **Saturday, August 21, 2021** with a maximum capacity of 8 persons from 9:00am-6:00pm daily. This is great news for our younger members to finally be able to use our newly renovated Baby Pool facilities.

### **MOVING CERTAIN F&B OUTLETS FROM "TYPE C" TO "TYPE D"**

In addition to the **Sundeck Pizza & Grill**, the entire 1st Floor at the Main Clubhouse, including the **Dining Room**, the **Cocktail Lounge** and the **Function Room** will move from a "Zone C" to a "Zone D" operation. In our endeavors to protect our members, guests and staff we have received a lot of positive feedback and the general consensus appears to be on greater community safety at the Club. Therefore, please note that as of **Monday, August 23, 2021** the LRC food and beverage outlets are divided into the following zones:

#### **Type C**

- Lotus Bistro
- Family Clubhouse

#### **Type D**

- Sundeck Pizza & Grill
- Dining Room
- Cocktail Lounge
- Function Room
- Private Dining Room

Please note that under **"Type D"** the following regulations are in force:

- Maximum 12 persons per table.
- Dine-in service until maximum 2:00am.
- At least two-thirds of persons at the same table for non-banquets must have received the first dose of COVID-19 vaccine.
- Maximum 180 participants in any one banquet. At least two-thirds of the total number of participants must have received the first dose of COVID-19 vaccine.
- Must use the "LeaveHomeSafe" mobile application.
- Except persons aged under 16 with an accompanying adult.
- Persons aged under 16 with an accompanying adult and persons aged 65 or above may opt to complete the record form.

Whilst such important decisions are always made in agreement between management and the General Committee, we do appreciate that this may not suit everyone. However, it is and will always be our paramount goal and objective to protect the LRC Community without too much operational inconvenience. These are difficult and unusual times and we are grateful for all of your support to continue to keep the Club a safe haven for everyone.
